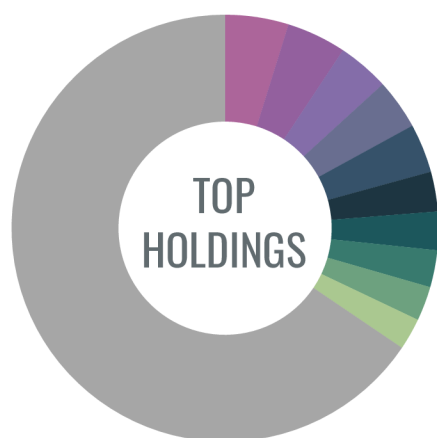


DEFENSIVE EQUITY STRATEGY

OVERVIEW

This strategy attempts to build a diversified portfolio consistently invested in most major economic sectors as defined by the S&P 500. We focus on approximately on average 25-35 high quality companies that have delivered stable and consistent returns through the business cycle. This strategy seeks a balance of income and growth with competitive returns. The goal of the strategy is to provide returns competitive with the S&P 500 with lower risk and volatility, as measured by beta.

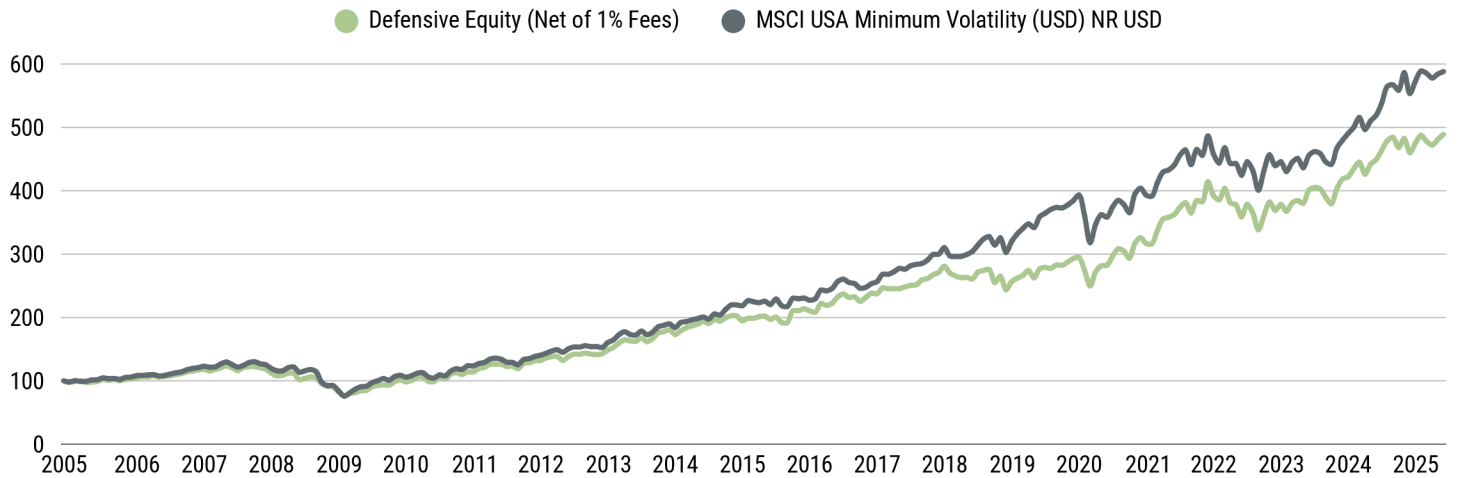

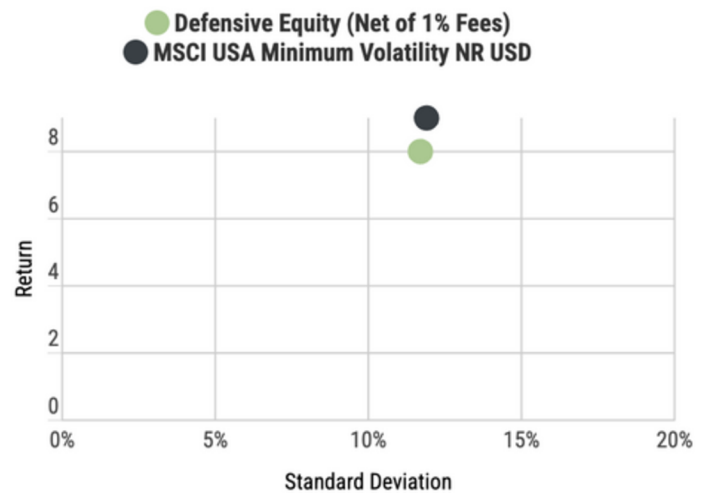

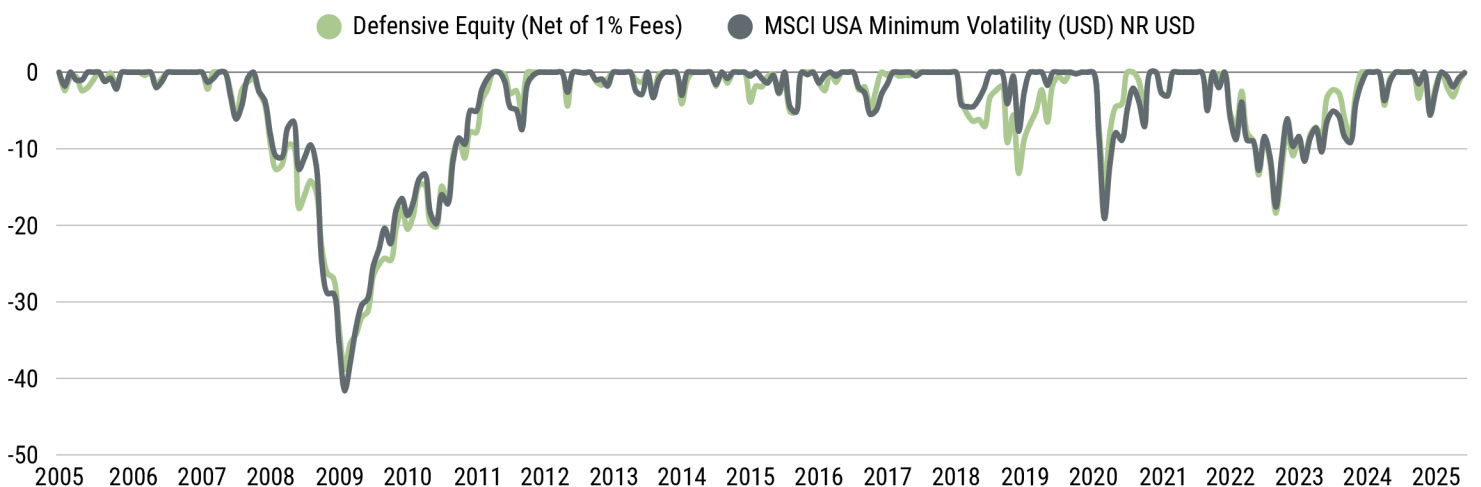
